

IOWA'S BOTTLE BILL

LITTER REDUCTION AND RECYCLING

Iowa's bottle deposit law, popularly known as the "Bottle Bill," passed in 1978 and includes all carbonated and alcoholic beverage containers. The program is self-supported and does not rely on taxes or unfunded mandates. Its impact is both environmental and economic. Here are some facts about the environmental impacts of the law through litter reduction and recycling:

HAS THE BOTTLE BILL REDUCED LITTER?

In 1980, two years after the Bottle Bill took effect, the Iowa Department of Transportation conducted a survey to determine the impact on litter. These findings imply that the new law expanded Iowans' consciousness beyond the value of recycling bottles and cans to an understanding of the importance of reducing litter and increasing recycling generally:

- Decrease in beverage container litter..... **77%^a**
- Decrease in total litter..... **38%^a**

HOW MUCH DO IOWANS RECYCLE?

- Number of beverage containers redeemed for deposit out of 1.9 billion sold..... **1.7 billion^b**
- Empty for-deposit containers returned per person in Iowa..... **575^b**
- Sales of drinks introduced since Bottle Bill passage that are not subject to the law..... **15%^c**

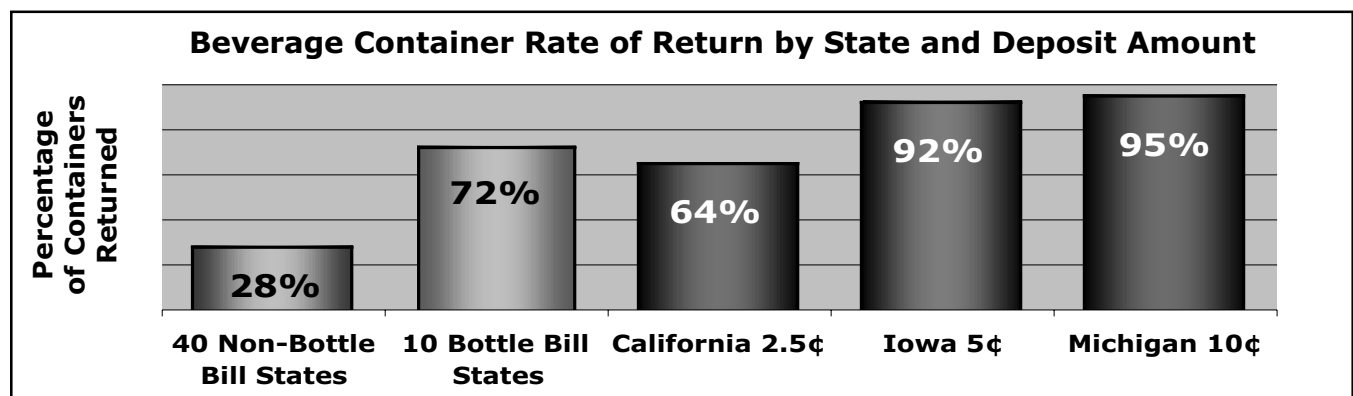
REDEEMABLE DEPOSIT & RECYCLING, IOWA VS. OTHER STATES

In the average bottle-bill state, beverage containers are 2 1/2 times as likely to be recycled as are containers in no-deposit states.

- Percentage of beverage containers returned in 10 states with deposits..... **72%^d**
- Percentage of beverage containers returned in 40 states without deposits..... **28%^d**

HIGHER DEPOSIT = BETTER RETURN RATES

- Percentage of beverage containers returned in **California (2.5-cent deposit)**..... **64%^e**
- Percentage of beverage containers returned in **Iowa (5-cent deposit)**..... **92%^d**
- Percentage of beverage containers returned in **Michigan (10-cent deposit)**..... **95%^e**
